# ANNUAL GENERAL MEETING 2024

#### 1. WELCOME, INTRODUCTIONS & APOLOGIES (SIMONE)

- Everyone welcomed to the 2024 AGM, including Councillor Gary Malcolm the Liberal Democrats councillor for Southfield ward
- Apologies from Suzanne Tanswell outgoing SPTRA Treasurer and Secretary

## 2. MINUTES OF LAST AGM (JULIE)

- Previous minutes from May 2019 have been reviewed no actions points were identified to discuss
- Due to the long period of dormancy, there will be no call to ratify these minutes

#### 3. CHAIRPERSONS REPORT (DON)

- Don Tanswell provided an overview of the 10 active years of SPTRA (2009 2019)
- During Covid Don advised that he sent out a proposal to close SPTRA, requesting any new team wanting to take over to submit a proposal.
- In conjunction with the remaining committee members, a new team formed with a new constitution; see agenda item 5.

#### 4. TREASURERS REPORT (DON)

- Don Tanswell provided a Summary of Accounts & Expenditure since last meeting
- SPTRA Bank Balance has reduced from £10,924 to £8,173.76 over the 5-year period
- Due to Covid, no subs have been requested from the membership
- An overview of the outgoing expenses was provided see attached for details

Following the Treasurer's report, Don Tanswell excused himself from the meeting due to illness.

#### 5. FUTURE OF THE ASSOCIATION (JILL AND TEAM)

- The proposed new format of the STAR Constitution was walked through,
- The new constitution is available at <u>STARChiswick.com</u>

Key points highlighted by the team:

- 1) The committee want to provide a framework for the community to utilise for their wants and needs
- 2) Hold social events throughout the year
- 3) Have Road Reps, these people will keep their roads informed and:
  - a. Manage WhatsApp groups
  - b. Utilise email where mobile tech is not possible
  - e.<u>b.</u>Utilise Email/door drops when <u>and word of mouth neither email nor where</u> mobile tech is <u>not</u> possible
  - d.c.Assist with the upkeep of the Membership Road Map
- 4) STAR Email Inbox: ensure all the committee have access to the email address where any items can be reviewed across the team rather than relying on a single people.
- 5) Have an "experts" database to utilise the wealth of knowledge across the community ensuring that people can be flexible in how much time they are able to commit with out having to fully commit to being a committee member.
- 6) Membership Road Map revive the list of residents across all the roads whilst complying with GDPR requirements
- 7) No Membership fee
  - a. whist there are no current outgoings we will not require any subs.
  - b. Small fees for events to ensure expenses are covered
  - c. Only anticipate collecting membership fees when needed for larger community issues
- 8) Use of current funds:
  - a. Insurance
  - b. Website
  - c. Banking fees
  - d. Legal advice for planning or other neighbourhood issues
  - e. Any other experts required to help

This is expected to be greatly reduced from previous run costs due to reducing the printing requirements and newly set up website subscription.

9) Slimmed down schedule of meetings to reduce costs and only hold AGM or an EGM when deemed truly necessary
